2. Further, a total of **3** candidates **i.e.01 candidate in Technician Gr.III (Blacksmith) & 02 candidates in Technician Gr.III (Welder)** have also been placed on Provisional Panel, for filling up of posts notified against E.N.No.01/2023 (GDCE-CSC).

4. If it is found at any stage of the recruitment/after appointment that the candidates do not fulfil any of the conditions of eligibility, his/her candidature/appointment will be cancelled and no appeal against such cancellation will be entertained.
