For validity of sports achievement, concluding day of championship/event shall be taken into account. Further, activeness in sports will be adjudged as per his/her performance during the trials.

(g) <u>In Golf</u>, for recruitment against the posts in Level-3/2 (Grade Pay Rs. 1900/2000); sportspersons having I.G.U. ranking upto 60, subject to single handicap i.e. less than 10 (in order of Merit/Amateur Merit list) shall also be eligible for recruitment. All the recruitments shall be at the minimum of scale of Pay.

All the championships conducted under the aegis of recognized International/National/State Sports Federation and also recognized by the Railway Sports Promotion Board will only be acceptable.

Sportspersons having sports norms for higher levels of pay and apply against the vacancies for the lower Levels of pay, will also be considered, provided he will not claim for higher Level after joining the Railways on the basis of sports achievements prior to joining Railways and the candidate gives an undertaking to this effect.

**RECRUITMENT PROCESS**: The recruitment will be based on performance during trials, assessment of sports achievements & educational qualification. The candidates who are found FIT in trials only will be considered for next stage.

#### 7. (I) SELECTION PROCEDURE:

- For this Recruitment, all eligible candidates will be called for the trials. Trials of the eligible candidates shall be conducted to assess the sports performance and suitability.
- ii) The dates for trials will be notified later and published in the South Western Railway website and will be held at Hubballi/Bengaluru/Mysuru or at any other notified places as decided by the Administration. While all out efforts will be made to inform the candidates well in advance, the candidates are cautioned that they may have to appear in the selection trials at short notice. The candidates are advised to regularly check the website for information in this regard.
- iii) Candidates should note that they are required to produce the originals of all documents enclosed with applications pertaining to educational qualification, caste, sports achievements, date of birth, minority income certificate and proof of identity viz. PAN card, Aadhar Card, Driving Licence etc. on the day of document verification and on the day trials failing which, the candidate will not be allowed to appear in the trials.
- iv) Any request for change in dates/venue for trials etc **shall not be entertained** under any circumstances.

#### (II) Distribution of Marks:

#### 8. EXAMINATION FEE/ EXEMPTIONS:

- (i) While applying, the candidates claiming fee exemption must submit necessary certificates i.e. SC/ST/OBC/ Minorities / EBC, in the format prescribed (i.e. 'Annexure A', 'Annexure B' (along with Annexure-B1), 'Annexure C', 'Annexure D').
- (ii) Applications not accompanied with examination fee, wherever required, will be summarily rejected.
- (iii) Minorities will mean Muslims, Christians, Sikhs, Buddhists, Jains and Zorastrians (Parsis).
- (iv) Economically Backward classes means those candidates whose annual family income is less than Rs. 50,000/- per annum. The following are authorized to issue income certificate for the purpose of identifying EBCs: -
  - (a) District Magistrate or any other revenue officer up to the level of Tahasildar.
  - (b) Sitting Member of Parliament of Lok Sabha for persons of their own constituency.
  - (c) BPL card or any other certificate issued by the Central Government under a recognized poverty alleviation programme or Izzat MST issued by Railways.
  - (d) Union Minister may also recommend for any persons from anywhere in the country.
  - (e) Sitting Members of Parliament of Rajya Sabha for persons of the district in which these MPs normally reside.
  - (f) The income certificate issued by the authorities mentioned above would have to be in the format prescribed at 'Annexure D' which is available on South Western Railway Website. This would have to be issued on the letter head of the issuing authority.

The examination fee should be paid in the form of crossed Indian Postal Order (IPO) only, from any Post office drawn in favour of Asst. Personnel Officer/Rectt., South Western Railway, Hubballi, payable at Hubballi.

### 8.1 Remittance of examination fee in any other form except Indian Postal Order will not be accepted.

- (a) IPOs issued before the date of issue of Employment notice or after the closing date will not be accepted and the application will be rejected.
- (b) The particulars of Indian Postal Order submitted as examination fee should also be indicated at the prescribed place in the application form.
- (c) Candidates must write their name, full address in the space provided in the Indian Postal Order.
- (d) The examination fee is not refundable/transferable/adjustable under any circumstances.

#### 9. HOW TO APPLY:

- **9.1** First, carefully read all the instructions given in the employment notification before filling the application form & ensure that you are eligible to apply.
- 9.2 Application as per the 'Annexure I' (along with 'Annexure II'), shall be submitted on A-4 size good quality paper. The Application can be downloaded from the websites of Railway Recruitment Cell, South Western Railway, Hubballi (www.rrchubli.in) OR South Western Railway, Hubballi (www.swr.indianrailways.gov.in). The application should be filled in English or Hindi language only. The applications in other than English or Hindi languages will be rejected.
- **9.3** The application should be filled by the candidate in his/her own handwriting and signed (**Not to be signed in capital letters**).
- 9.4 The candidate has to affix/paste (not to be pinned/stapled) one recent passport size colour photograph without wig, cap or coloured glasses (not older than two months), duly attested/self attested by signing partially on the application and partially on the photo in the space provided for the purpose. Candidate is also required to enclose one extra passport size photograph (same as the one affixed/pasted on the application) along with the application.

#### 10. WHOM TO APPLY:

The cover shall be super scribed as "Application for Group 'C' post against Sports Quota (Open Advertisement Scheme) for the year 2022-23" and should reach the Addressee on or before 17.45 Hours of 16.01.2023.
- 10.2 For candidates residing in Assam, Meghalaya, Manipur, Arunachal Pradesh, Mizoram, Nagaland, Tripura, Sikkim, Jammu & Kashmir, Lahaul & Spriti districts and Pangi Sub-Division of Chamba District of Himachal Pradesh, Andaman & Nicobar and Lakshadweep Islands and the candidates residing abroad, the closing date for receipt of applications by post will be 17.45 Hours of 31.01.2023.

#### 11. MEDICAL EXAMINATION:

The Candidates recommended for appointment will have to pass the requisite medical fitness test(s) conducted by the Railway Administration to ensure that the candidates are Medically FIT to carry out the duties connected with the post. Only those candidates who are Medically FIT would be empanelled for appointment.

#### 12. **GENERAL CONDITIONS**:

- **12.1** The name and initial of the candidate and father's name appearing in school/college certificates and in sports certificates should be one and the same.
- 12.2 The specific position [Forward/Chess/Right Wing Position/Left Wing Position/100 mts & 200 mts/800 mts/3000 mts Steeple Chase/Doubles/All Rounder/Batsman/Left Arm Spinner/Medium Pacer/Wicket Keeper/Golf/81 Kg/50m/100m/200mts Back Stroke/Free Stroke/Singles/Doubles/All Rounder/Attacker/Center Position] played in the particular game/event if applicable should be mentioned in the application form (Annexure I) and 'Annexure II' without fail.
- 12.3 The candidates serving in any Government/Public Sector Undertaking including Railways should apply through proper channel or should apply directly with 'NO OBJECTION CERTIFICATE' from the employer to avoid delay. Advance copy of the application from such candidates without 'NO OBJECTION CERTIFICATE' from the employer will not be entertained. Please note that no application received after the prescribed date will be entertained.
- **12.4** The applicant is liable to be appointed against any suitable posts in Level-5/4 and Level-3/2 of Railway Services (Revised Pay) Rules, 2016 as the case may be, anywhere on South Western Railway.
- **12.5** Candidates selected will have to undergo prescribed training course as applicable for the post as per existing instructions.
- **12.6** Canvassing in any form shall disqualify the candidature.
- 12.7 The candidates should be in readiness to appear for the trials at a short notice after the last date for submission of application is over. - Please obtain caste certificates in the prescribed proforma from the appropriate authority and produce the original certificate at the time of verification. Caste Certificates issued by the authorities other than those authorised, will not be considered. - **12.9** No TA/DA/Accommodation will be given for appearing in the document verification/selection trials. Applicants will have to bring their own kit for attending selection trials. They may also be required to stay during the selection for 4-5 days, for which they have to make their own arrangements.
- **12.10** Candidates applying for more than one game/event shall submit separate applications with separate IPO as fee and documents for each event.
- **12.11** Sports persons having sports norms for higher levels and applied against the vacancies for the lower levels can be considered. However, he/she will not claim for higher Grade Pay after joining the Railways on the basis of sports achievements prior to joining Railways.

- **12.12** Selected candidates will have to submit 'Service Bond' of 5 years at the time of appointment.
- **12.13** Sports person recruited against sports quota shall be terminated from service summarily, if the information and documents furnished by him/her for recruitment are found incorrect/fake at any stage.
