1. South Western Railway invites applications online from eligible Indian Nationals for recruitment of 03 (Three) posts in Level-2 and 08 (Eight) posts in Level-1 of the Railway Services (Revised Pay) Rules, 2016 against Scouts & Guides Quota through Open Advertisement for the year 2025-26 as under:

2) These posts are open to all communities and there is no reservation for any community.

#### 2. EDUCATIONAL AND SCOUTS & GUIDES QUALIFICATIONS:

#### 2.1 Minimum Prescribed Educational Qualification:

**NOTE 2:** Persons if considered for appointment to the category of Clerk-cum-Typist should acquire the requisite typing proficiency within a period of two years from the date of appointment and till such time their appointments to this category will be treated as provisional.

- 2.2 **Scouts & Guides Qualification:** The following qualification would apply for recruitment of Scouts & Guides to posts in Level-2 and Level-1.
  - a) A President Scout/Guide/Rover/Ranger <u>OR</u> Himalayan Wood Badge (HWB) holder in any section;
    - (Note: As per Railway Board's letter No.E(NG)II/2023/RR-2/1 dated 10.04.2024, with reference to admissibility of **provisional certificates** of a President's Scout / Guide / Rover / Ranger (or) Himalayan Wood Badge (HWB) Holder, it is mentioned that such candidates will be provisionally allowed to participate in the selection procedure. However, their empanelment/appointment will be regulated as per procedures laid down in para 1(iii) of Board's instructions vide RRCB Circular No.01/2000 dated 07.02.2000)
  - b) Should have been an active member of a Scouts organization for the last 5 years. The 'Certificate of Activeness' should be as per **Annexure-I**; and
  - c) Should have attended two events at National level <u>OR</u> All Indian Railways' level <u>AND</u> two events at State level as per **Annexure I**.

#### 3. AGE LIMIT AND RELAXATION (As on 01-01-2026).

- 3.1 **Those applying for posts in Level-2:** The candidate must have attained the age of 18 years and must not have attained the age of 30 years as on **01.01.2026** i.e.must have been born not earlier than 02<sup>nd</sup> January 1996 and not later than 01<sup>st</sup> January, 2008.
- 3.2 **Those applying for posts in Level-1:** The candidate must have attained the age of 18 years and must not have attained the age of 33 years as on **01.01.2026** i.e.must have been born not earlier than 02<sup>nd</sup> January 1993 and not later than 01<sup>st</sup> January, 2008.

**NOTE 1**: The candidates should note that, only the Date of Birth as recorded in the Matriculation/ Secondary Examination Certificate, School Leaving Certificate or 12<sup>th</sup> or an equivalent certificate as on the date of submission of application will be accepted by the administration and subsequent request for its change will not be considered or granted.

#### 4. EXAMINATION FEE:

(B)	For candidates belonging to SC/ST/Ex-Servicemen/ Persons with disabilities (PwBD), Women, Minorities and Economically Backward Classes (EBCs)	:	Rs.250/- (Two Hundred and Fifty only) with a provision for refunding the same to those who actually appear in the written examination after deducting the bank charges.

- (i) While applying, the candidates claiming waiver of fee must submit necessary certificates i.e. SC/ST/Ex-Servicemen/ Persons with disabilities (PwBD), Minorities and Other Backward Classes (OBCs) in the format prescribed (i.e.'Annexure-A', 'Annexure-F, G, H', 'Annexure-D' 'Annexure-E').
- (ii) Fee should be paid ONLINE using internet banking or debit/credit cards (service charges apply for all banks which will be borne by the candidates.
- (iii) Applications not accompanied with prescribed examination fee, will be summarily rejected.
- (iv) Candidates belonging to SC/ST and claiming waiver of fee, should upload caste certificate in the proforma attached as Annexure-A to the notification and should produce the original certificate at the time of Document Verification, failing which he/she may be disqualified. This is strictly required as per Chapter-XI of the Brochure (published by Govt. Of India, Ministry of Personnel, Public Grievance & Pensions Department of Personnel Training, New Delhi) on verification of the claims of Schedule castes and Schedule Tribes.

- (v) For claiming waiver in examination fee, minority candidates should furnish 'Self Declaration' as mentioned in **Annexure-C** along with the application form Minorities will mean Muslims, Christians, Sikhs, Buddhists, Jains and Zorastrians (Parsis).
- (vi) For claiming exemption in examination fees, the candidates claiming waiver in fee under Other Backward Classes (OBCs), should furnish form of Income Certificate Other Backward Classes (OBCs) in the proforma attached as Annexure-E to the notification. Other Backward Classes will mean the candidates whose family income is less than Rs.50,000/- per annum.
- (vii) Persons with disability only those candidates would be eligible for reservation in services / posts who suffer from not less **than 40% of relevant disability**.
- (viii) Candidates should provide the correct details of beneficiary Bank Account in which they would like to receive the refund viz. beneficiary name, Bank name, Account number and IFSC Code while filling up the application form to facilitate refund of fees to the eligible candidates as per Para 4 (A) & 4 (B) above after deducting bank charges. Fee in respect of candidates who are found ineligible and eligible candidates who does not attend written examination shall not be refunded.
- (ix) Candidates applying for posts both in Level-1 and Level-2 have to pay the **fees separately**.

#### 5. Community Certificates to be uploaded:

- (i) Candidates belonging to SC/ST should upload caste certificate in the proforma attached as **Annexure-A** to the notification and should produce the original certificate at the time of Document Verification, failing which he/she may be disqualified.
- (ii) OBC candidates are required to upload Caste Certificate with Non-Creamy layer certificate valid for the current year 2025-26 in Central Government format (as per Annexure-B) issued on or after 01.04.2025 by the Competent Authority. Certificates should contain Caste, Date of Issue etc. and bear the seal of the Issuing Authority.

OBC Candidates who have applied for latest OBC Certificate with Latest Non-Creamy layer certificate are required to upload the existing OBC certificate in Central Government format (as per Annexure-B) issued by the Competent Authority and are also required to invariably fill and upload the Self-Declaration form regarding current status of Non-Creamy Layer (As per Annexure-C)

(iii) Candidates belonging to community/category in the table at para 3.3 shall be eligible for age relaxation and at para 4 (B) for claiming exemption in examination fee as applicable on uploading of requisite valid certificates only.

#### 6. **HOW TO APPLY**:

- 6.2 First, carefully read all the instructions given in the employment notification before filling the online application form.
- 6.3 The path is as follows: About Us > RRC/SWR > Notification > 'Notification for Recruitment against Scouts & Guides Quota in Level-1 and Level-2 posts for the year 2025-26'. Click on "New Registration" for registering.
- 6.4 Login as instructed.
- 6.5 Fill up details and upload the latest/recent photograph, signature, documents (i.e., Educational Qualification, Certificate for proof of Date of Birth, Scouts & Guides Certificates, caste certificate etc. Certificates should be self-attested.
- 6.6 Click on "Examination Fee" and continue to pay

- a) Select payment category and enter all the required information and Click on "Next"
- b) Verify the payment details and click on "Next"
- c) Choose the payment option from the available options and perform the transaction
- d) On successful completion of the transaction, e-receipt with the date entered by the candidate will be generated which should be saved/printed and retained by the candidate and may be secured till recruitment process is completed.
- e) If the online transaction is not successfully completed, please make payment online again.

#### 7. Document to be uploaded along with application form:

#### 7.1 Passport size colour photograph:

SCANNED PHOTOGRAPH/SOFT COPY OF PHOTOGRAPH — Candidates are required to upload their colour photograph (which should not be older than three months from the date of application, JPG/JPEG format, size of the file should be less than 50 kb) with clear front view of the candidate without cap and sunglasses. Candidates may note that RRC/SWR may, at any stage, reject the applications for uploading old/unclear photograph or for any significant variations between photograph uploaded in the Application Form and the actual physical appearance of the candidate. Candidates are advised to keep two additional copies of the same photograph ready with them for bringing at the time of Document Verification, later.

- 7.4 10<sup>th</sup> Certificate in proof of Date of Birth. If Date of Birth is not mentioned in the 10<sup>th</sup> Certificate, Date of Birth certificate should be uploaded mandatory.
- 7.5 Certificate for Fee exemption/ Age relaxation i.e.SC/ST/OBC/OBC/ Minorities/Physically Handicapped certificate/ Income Certificate/ Declaration by candidate regarding Scouts & Guides Activities etc. (Annexure I, A, B, C, D, E, F, G & H)
- 7.6 Certificate in proof of academic qualification as per para 2.1 of this notification shall be uploaded in **Single PDF**.
- 7.7 Certificate in proof of Scouts and Guides Qualifications as per Para 2.2 of this notification. (Annexure-I) shall be uploaded in **Single PDF**.
- 7.8 Fee receipt of successful payment should be downloaded.
- 8. <u>SEPARATE ONLINE APPLICATION</u>: The candidate who desires to apply for both the posts in Level-2 & Level-1 should apply separate online applications along with documents with separate IPO/IPOs as fees, for each level of posts.

#### 9. RECRUITMENT PROCESS:

The candidates, who apply in response to the notification and are found eligible for consideration for appointment against Scout & Guides quota, will be assessed on the basis of following criteria:

#### 10. SYLLABUS:

History of Scouting/Guiding; Law and Promise; Organisation – 'Distt. & State Level'; Training Center – Distt. & State level; Knowledge of Books; Scouting for Boys/Guiding for Girls in India; Motto left hand shake; Salute; Prayer; Flag Song; National Anthem; Know the National and Scouting flags; Social Services at various occasions; Hiking; Proficiency Badges, How these are earned?; Stages in Scouting/Guiding. Thinking Day; Progressive Training of Scouts/Guides/Rovers/Rangers; Pioneering; Handicrafts; Indian Railway/Jamborette; National Jamboree; Jamboree on the Air.

Organisation at National level, National Training Centres WAGGGS/WOSM-Uprashtrapati Award Competition; Prime Minister Shield Competition, Community Development programmes, Aims and Methods of Scouting, How Scouting is useful in producing better citizens?

11. <u>MEDICAL EXAMINATION</u>: The Candidates recommended for appointment will be subjected to requisite medical fitness examination conducted by the Railway Administration to ensure that the candidates are Medically FIT to carry out the duties connected with the post. Only those candidates who are Medically FIT would be empanelled for appointment.

#### 12. IMPORTANT CONDITIONS:

- 12.1 The candidates should ensure that they fulfil all eligibility conditions prescribed for the Scouts & Guides Quota. Eligibility of the candidates for the post notified in this notification would be decided on the basis of the information furnished by them in ONLINE application. He/she is required to check and upload all necessary documents mentioned in para 7 along with his/her ONLINE application. No any other documents shall be entertained at the further stage of recruitment and the RRC/SWR reserves the rights to reject any application, not fulfilling the eligibility condition/s. If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in the application is false/incorrect or the candidate has suppressed any relevant information or the candidate otherwise does not satisfy the eligibility criteria for the post(s), his/her candidature will be cancelled forthwith.
- 12.2 Candidates belonging to community/category in the table at para 3.3 seeking age relaxation/Fee exemption have to produce requisite original certificates as given in Annexures at the time of document verification, otherwise their candidature will be summarily rejected.

- 12.3 The candidates should be in readiness to appear for the written test at short notice. Information regarding call letter will be sent through SMS and e-mail alerts on their registered mobile numbers and E-mail IDs indicated in their ONLINE application.
- 12.4 Candidates must bring certificates of birth, education qualification, the certificates pertaining to Scouts & Guides and other relevant documents, all in original on the day of document verification, without which they shall not be permitted to appear for the document verification.
- 12.5 The name & initial of the candidate & father's name appearing in School/College certificates and in Scouts & Guides certificates should be one and the same. There should be no difference. Differences if any found, should be corrected from appropriate authorities before the submission of application.
- 12.6 The candidates serving in any Government Department or Public Sector Undertaking including Railways should apply through proper channel or should apply directly with 'NO OBJECTION CERTIFICATE' from the employer to avoid delay. Advance copy of the application from such candidates without 'No Objection Certificate' from the employer will not be entertained.
- 12.7 The applicant is liable to be appointed against posts in Level-2 or Level-1 and will be posted in safety category posts or in the field as the case may be, anywhere on South Western Railway and Rail Wheel Factory, Yelahanka, if selected.
- 12.8 Candidates recommended for appointment will have to pass the requisite Medical Fitness Test, as per the standards prescribed for the selected post. Candidates qualifying in examination(s) for these posts but failing in prescribed medical examination(s) will not under any circumstance be considered for any alternative appointment.
- 12.9 Candidates who are selected will have to undergo prescribed training course as applicable for the post as per existing instructions.
- 12.10 Canvassing in any form shall disqualify the candidature.
- 12.11 Candidates are advised to take print out of their application and fees receipt which may be required to be produced at the time of written test/document verification.
- 12.12 The candidates belonging to SC/ST/OBC shall submit caste certificates in the prescribed proforma from the appropriate authority (Annexure-A). OBC candidates shall also submit a latest OBC Non-creamy layer certificate in Central Government format issued by the Competent Authority to get the benefit of age relaxation in the proforma 'Annexure-B' & 'Annexure-C'. The original certificate must be produced at the time of document verification otherwise their candidature will be summarily rejected. The candidature of the candidates submitting caste certificates issued by the authorities other than those authorised, are liable to be disqualified. As large numbers of candidates are producing certificates issued by authorities different from appropriate authority, candidates are advised to strictly comply with the instructions.
- 12.13 No TA/DA/Accommodation will be given for appearing in the Written Examination/ Document Verification. They may also be required to stay during the document verification written examination for 4-5 days, for which they have to make their own arrangements.
- 12.14 The candidates admission at all stages of the recruitment will be purely provisional subject to fulfilling the prescribed eligibility conditions and instruction of notification.
- 12.15 Selection will be conducted separately for Level-2 and Level-1. Dates for written examination will be notified only on RRC/SWR website i.e.www.rrchubli.in. Admit card can be downloaded from RRC/SWR website i.e.www.rrchubli.in

- 12.16 Selection of the candidate by the Railway Administration does not confer any prescriptive right in the candidate for the post.
- 12.17 Candidates selected against Scouts & Guides quota shall be terminated from service summarily if the information and documents furnished by him/her for recruitment are found incorrect/fake at any stage.

### 13. PROHIBITION OF THE POSSESSION OF MOBILE/PHONES AND OTHER COMMUNICATION/ ELECTRONIC DEVICES ETC.:

- a) Possession/use of Mobile phones, Pagers, communication/recording devices and any other electronic devices are strictly prohibited inside the premises where the examination is being conducted. Any violation of these instructions shall result in cancellation of the candidature without prejudice to other criminal/disciplinary action including debarment from future examinations.
- b) The candidates are advised, in their own interest, not to bring any of the prohibited items including Mobile phones, pagers or any other communication devices, any book or portion thereof, manuscripts, log tables, slide rulers, calculators, baggage, ladies hand purse etc., to the venue of the examination, as arrangement for safe-keeping cannot be assured.
- 14. Candidates are also advised **not to bring any valuable/costly items to the examination halls**, as safe-keeping of these items cannot be assured. Administration will not be responsible for any loss in this regard.

- 15.8 Copy of certificates in proof of claiming age relaxation as per para 3.3.

#### 16. <u>INVALID APPLICATIONS</u>:

Applications with the following short comings will be summarily rejected.

- 16.1 Applications without scanned signature/ scanned signature in capital letters.
- 16.2 Applications without scanned photograph.
- 16.3 Applications with scanned photo wearing sunglasses or with cap or with wig or coloured glasses or disfigured/small size or unrecognisable photo.
- 16.4 Not possessing the prescribed academic and Scouts & Guides discipline qualification along with the certificate of activeness as per Annexure-I for the post on the date of submission of application.
- Application without community certificate (as per para 15.5) and certificates without proof of claiming age relaxation/fee relaxation, wherever applicable.
- 16.6 Application of over-aged or under-aged candidates and also where date of birth certificates uploaded are illegible, date not filled in or wrongly filled.
- 16.7 Application without proof of age relaxation claimed as per para 15.6, 15.7 & 15.8.
- 16.8 Applications without prescribed examination fee.

- 16.9 Certificates not uploaded/uploaded certificate are not readable as per para 7 of this notification.
- 16.10 Declaration by the Group Leader, countersigned by State/District Commissioner or State/District Secretary (Scouts & Guides) (Annexure I) and certificate of activeness by the concerned authorities as sought in form (Annexure I).
- 16.11 Applications without Scouts & Guides activities not enclosed as per Annexure-I of the application.
- 16.12 Multiple application with minor changes of information / facts or varied details for same post.
- 16.13 Incomplete applications in any form/any irregularities noticed are liable to be rejected.
- 16.14 Applicants who are not fulfilling norms for recruitment as per para 2.1, 2.2 & 3 of this notification.
- 16.15 The candidature of candidate may also be rejected if (i) the candidate submits multiple applications for the same post and category: (ii) the candidate submits multiple applications with the different community for the same post and category: (iii) the candidate submits multiple applications with a different photo (face) for same post and category and (iv) the candidates submits multiple applications with a different documents for the same post and category.
